- 1. Financial status update: budget may be \$50K less due to a few gas companies not paying taxes; county estimates \$100K below next year's budget.
- 2. The reserve may help, but caution needed in terms of future revenue.
- 3. Payroll has been taken over by the Library Director.
- 4. Next year's Budget will be reviewed at the October 21<sup>st</sup> meeting; Public review will be at the November 18<sup>th</sup> meeting.
- 5. August numbers are at or above in most categories with some expenses for Kline property and Sunnyside pit.
- 6. An amended budget may have to be filed if necessary.

#### 7. Other Items

1. Need to find a permanent Board meeting place; Fairgrounds would be \$432 for 2 hours a month per year. Suggestions made to look at room above Sunnyside Market and Ecosphere.
