- 4. HB24B -1001-SDA, Ann Terry answered questions regarding this. Summary:

Our existing reserves are safe because we obtained them prior to this law passing.

HB24B-1001 affects our ability to collect money. We cannot collect more than 10.5% above our base year over a two-year period. This collection of money includes tax revenue, grant revenue, other gifts and fund raising efforts.

As long as we don't take in more than the 10.5% over two years, we do not have to return any money to taxpayers. (How much we spend doesn't matter; only how much receive). If we have money available, we are permitted to move it into our reserve funds, as long as we haven't collected more than 10.5% above our base year, over a two-year period.

As a district, we have the right to select any year as our base year that we would like. 2024's actual revenue (tax levy, other county revenue, grant revenue, ASEP revenue, interest revenue, etc.) equaled \$647,700. This is our highest revenue amount.

We are able to de-bruce again, if we would like to and want to have another initiative brought before voters.

8. Other Items

 - We are down by 2 Board members; county will be notified to make this announcement in the Herald.
 - It is important to keep talking to people in our district to join the Board
- b. Board Member Positions
